The Festival is Long Beach's premier showcase of Pacific Islander culture. Last year over 20,000 people visited the Festival!

Tafesilafa'i is a civil rights, social justice, faith-and community-based organization that functions as an organic clearinghouse for things Pacific Islander. It is an outreach and service provider that advocates on behalf of Pacific Islanders in the greater Long Beach area. Its mission is to ensure the political, educational, social and economic equality of Pacific Islanders. It is a think tank where issues about Pacific Islanders, such as their languages and cultures are investigated, presented, debated and where solutions are proposed and implemented.

In response to the need for Pacific Islander youth to have a safe place to celebrate their culture, language, dance and customs, Tafesilafa'i Cultural Festival was formed in 1996. Twenty years later, in addition to sponsoring its week-long annual cultural festival, Tafesilafa'i is now a major social services provider and partner in the local and national conversations about Pacific Islanders.

The 20th annual Tafesilafa'i Pacific Islander Festival will be held from Friday July 22th, 2016 through Sunday July 24th, 2016 at Shoreline Aquatic Park located at 1308 Golden Shore, Long Beach, CA 90802. Festival's Policies and Guidelines:

- 1. Tafesilafa'i, Inc. reserves the right to approve or deny any vendor booth application for any reason.
- Tafesilafa'i, Inc. reserves the right to change the designation of your booth according to the information provided. Should we change your designation, we will inform you immediately. If the new assigned space is unacceptable to you, you will have the option to withdraw from the event if new status is not acceptable and receive a full refunding of all funds paid by you or your organization.
- 3. It is understood that there will be no refunds in case of inclement weather, acts of nature, forfeiture or by restrictions of government agencies to amend or cancel the event, over which festival has no control.
- 4. Absolutely no subleasing of booth space or surrounding areas. If anyone subleases any or a portion of his/her space without permission from Tafesilafa'i Inc., you will not be allowed to operate the booth and you will forfeit all fees paid.
- 5. Absolutely no beverages of any type should be sold from any booth. Festival has the exclusive right to sell any and all beverages.
- 6. No firearms, ammunition, alcoholic beverages, or drugs are allowed on Festival grounds.
- 7. No lewd or suggestive material or products allowed.
- 8. Food Booth Vendors: No live animals are permitted within your booth area.
- 9. Food Booth Vendors: are responsible for disposing of any grease or cooking oil and/or coals used in the preparation of the food.
- 10. Food Booth Vendors: A copy of your current health or catering permit is required to be submitted with this application and payment.

- 1. Tafesilafa'i agrees to provide the following:
 - 10x10 booth space located on the festival grounds at the Aquarium of the Pacific, 100 Aquarium Way, Long Beach, CA 90802. Vendor location will be assigned based on availability and receipt of full payment of booth fees. Vendor will be assigned to space number_____.
 - Tafesilafa'i will provide a 10x10 tent, 8 foot table and two chairs. An additional 10x10 booth space behind your original space can be secured for an additional \$200 fee. Vendor will be charged the following fee for any missing items provided by the festival: 8 foot table-\$60 and chair-\$30. ABSOLUTELY NO MOVING OF TENTS OR ADDITION OF TENTS WITHOUT CONSENT FROM TAFESILAFA'I!
- 2. Vendor to provide the following:

- 3. Vendor shall comply with all terms and conditions as provided for in The Festival Vendor letter attached.
- 4. Vendor will hold Tafesilafa'i and the Aquarium of the Pacific harmless of all liabilities as a result of vendor's activities or representations at the festival.
